Credit Sense Rewards Sweepstakes – Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Sponsor

The Credit Sense Rewards Sweepstakes (“Promotion”) is sponsored by **Lincoln Park Community Credit Union (“Sponsor”)**, located at 1400 Emmons Blvd, Lincoln Park, MI 48146.

2. Eligibility

The Promotion is open to legal residents of the United States who are eligible for membership at Lincoln Park Community Credit Union.

Entrants must be **18 years of age or older** at the time of entry.

Employees, volunteers, directors, and officials of the Sponsor, and their immediate family members (spouse, parent, sibling, child) and household members, are not eligible to participate or win. Void where prohibited by law.

3. Promotion Period

The Promotion begins on **May 18, 2026**, and ends at **11:59 PM on June 8, 2026** (“Promotion Period”).

4. How to Enter

To enter the Promotion, participants must complete the following steps during the Promotion Period:

- Log in to **Online (Home) Banking**
- Open **Credit Sense (SavvyMoney)**
- Check their credit score

Completion of these steps will automatically generate one (1) entry into the Promotion.

Limit **one (1) entry per person** during the Promotion Period.

5. Winner Selection

One (1) winner will be selected in a random drawing from all eligible entries received.

The drawing will take place on or about **June 9, 2026**.

All decisions by the Sponsor are final.

6. Prize

One (1) prize will be awarded:

- **\$150**, deposited into the winner's Lincoln Park Community Credit Union savings account within ten (10) days of winner confirmation.

The prize is non-transferable and no substitution will be made except at the Sponsor's sole discretion. The winner is responsible for any applicable taxes.

7. Winner Notification

The winner will be notified using the contact information associated with their account.

If the winner cannot be contacted within a reasonable timeframe, an alternate winner may be selected.

8. Publicity Release

By entering, participants grant Lincoln Park Community Credit Union permission to use their name and likeness for promotional purposes, including but not limited to website, social media, and marketing materials, without additional compensation, unless prohibited by law.

9. General Conditions

By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor.

The Sponsor reserves the right to cancel, suspend, or modify the Promotion if fraud, technical issues, or other factors impair the integrity of the Promotion.

10. Limitation of Liability

The Sponsor is not responsible for lost, late, incomplete, or misdirected entries.

By entering, participants agree to release and hold harmless Lincoln Park Community Credit Union and its affiliates from any liability arising from participation in the Promotion or acceptance of any prize.

11. Privacy

Information submitted in connection with the Promotion will be used in accordance with Lincoln Park Community Credit Union's Privacy Policy.

12. Odds of Winning

Odds of winning depend on the number of eligible entries received.

13. Additional Disclosures

Membership eligibility is required. Contact Lincoln Park Community Credit Union for full membership details.
